## The concept for the development of initiative budgeting in the Suojärvi urban settlement within the framework of the "EmPaci" project

This document describes the expected results of work on the implementation of certain elements of the initiative budgeting (IB) technology in the Suoyarvi urban settlement within the framework of the EmPaci project in 2020-2021.

Taking into account the nature of the task set within the framework of the Project, the time frame and the estimated amount of funding, it is proposed to focus on creating a basic organizational infrastructure, that is, projects of administrative processes, local regulations, methodological recommendations and document templates that ensure the execution of proactive budgeting processes, as well as conducting measures aimed at increasing the readiness of administration staff and residents of the Suojarvi State Enterprise to be actively involved in information security processes.

Due to the fact that currently a federal bill on proactive budgeting at the municipal level has been developed and is being adopted (Bill No. 893063-7 On Amendments to the Federal Law "On General Principles of Organization of Local Self-Government in the Russian Federation" (in terms of legal regulation issues of proactive budgeting)), it seems appropriate to take into account the provisions of this draft law in the formation of the developed processes and documents.

Thus, when forming and implementing work plans in 2020, at least three framework packages of requirements will be taken into account: the requirements of the Suojarvi State Enterprise Administration (the customer's framework), the requirements of the current and future legislation (regulatory framework) and the requirements of the EmPaci project (the contractor's framework). The following describes the key elements of each of the framework inputs and formulates the main expected results of the Project in 2020.

4.1 Development of a model suitable for the city (analysis of the situation, needs, problems of administration and residents)

4.2 Development of documentation, including:

A. Legal and regulatory framework for launching the information security process in Suojarvi:

- 1. drawing up a brief Regulation on the project, its timing and budget, reflecting the principles of project implementation, the powers of the participants, the procedure for holding meetings and the procedure for resolving disputes.
- 2. development of the Regulations for meetings, voting and selection of budget commissions in the region;
- 3. development of the Regulations for training members of budget commissions;
- 4. formation of an approximate list of the schedule of voting and drawing of lots;
- 5. Development of the Regulations for the examination and implementation of the winning initiatives and the form of the Plan for the implementation of the initiative
- 6. formation of a calendar of IB events, involvement of professional experts in the process of lecture and group work.
- B. Coordination of a set of documents with the local administration.
